- One portrait photograph of the choreographer
The file name for the photograph should take the format "Choreographer's name"
- Profile of the individual choreographer
For a Competition I application as a group or company, a profile of each of the choreographers is required.
- Video of the work being submitted
 - Video data should be in **mp4 or avi** format (uploaded via the website or on a DVD).
 - The video submitted for the preliminary judging must be of the same work that would be performed in the final judging.
 - Use the name of the choreographer as the file name for the video file. Do not use the title of the work as the file name.
 - The video should minimize the use of special visual effects possible in video art.
 - The file uploaded or Video data must contain only one work, which must comply with the time limit stated above.
- Submit a copy of either a flyer or a performance contract related to a previous performance of a work you have choreographed.

As applying from WEB form, not required to be filled out this second page.
